**BOARD DISCUSSION**

**A. Middle School Tech Update**

Ms. Ridley (District Administrator) and Mr. Long (District Administrator) shared a handout which illustrated Design Thinking and Middle School Tech electives. Design Thinking includes five steps (Discovery, Interpretation, Ideation, Experimentation, and Evolution). Students will have experiences including coding, game design, and digital citizenship. Course implementation is set for 2018-19.

**B. Professional Learning**

Mr. Cybulski (Assistant Superintendent) shared thoughts on the Professional Learning Steering Team. Ms. Ridley shared thoughts on the Innovator's Mindset (book), and Mr. Kessler (Director) and Mrs. Brennan (Director) shared thoughts on the Literacy Leadership Team, Lab Site and the Math Leadership Team. Next steps are being explored. A handout was provided.

**C. AP Course Update**

Mrs. Brennan and Mr. Boles (Assistant Principal) provided a breakdown on students enrolled in AP classes. (Currently 45% of students in grades 10-12 take one or more AP classes.) Mr. Boles shared data which illustrated correlation between AP class election and college graduation. Data was provided indicating the number of students currently and historically enrolled in each AP course (by subject).


