A. Online Bullying Prevention Course

Bridgette Smiley communicated the purpose of the course. This online course is utilized as a TIER II behavior support (intervention) for students who have demonstrated “bully-like” behavior as an educational and reflective tool, that builds empathy in hopes to stop the behaviors before they worsen, become chronic, and a true bullying incident occurs.

Course Objectives:

- Learn the definition and types of bullying.
- Gain knowledge of bullying facts and statistics.
- Explore what others feel like when they are bullied to build empathy.
- Take an assessment on the course content to check for understanding.
- Complete/Submit a reflection at the conclusion of the course.

Process:

- Students are assigned the course by a staff member to complete the course during school hours; detentions, in-school suspensions, or another designated time.
- Upon completion of the course and reflection, the reflection is submitted to the building leader.
- The principal, assistant principal, school counselor/psychologist or other designee, will have a follow up discussion on the learning, reflection and/or additional supports a student may need.

B. Children’s Hospital Partnership Update

Rachel Searcy, Coordinator for Special Programs, and Emily Meyer, School-Based Therapy Coordinator for Cincinnati Children's Hospital Medical Center shared the 2017-18 MindPeace Partnership data. The data was gathered by MindPeace documenting the mental health referrals made by Oak Hills staff to our Children's Hospital school-based therapy providers. During the 2017-18 school year, there were 420 new referrals made, with a total of 324 students served by a Children's Hospital therapist located at an Oak Hills building. All elementary schools added services during the 17-18 school year, which allowed for coverage of services at each of the 9 buildings. The Children's Hospital partnership has proven to be a critical district resource in helping support our students' social-emotional and mental health needs.

Mr. Bain communicated that Delhi Par 3 will be developed into 31 single family homes. Assuming Delhi Par 3 is fully developed, the subdivision would generate an additional \$150,000.

Mrs. Hunter shared an article with the Board on the correlation between mental health staffing and student safety.


