**VI. BOARD DISCUSSION**

**A. College Credit Plus (CCP) Update**

- Travis Hunt (Principal Oak Hills High School) and Dan Boles (Assistant Principal Oak Hills High School) explained the CCP partnerships with the University of Cincinnati and Cincinnati State. Also explained was the Transfer Assurance Guide which communicate how credits are transferred/accepted at state universities. In 2021, the district had 144 students complete 1,262 college credit hours which cost the district \$91k as well as textbook fees. The district is interested in expanding opportunities for students with additional offerings at Cincinnati State. The district also has partnerships with Sinclair Community College.

**B. Mission/Vision/Core Beliefs**

- Tim Cybulski (Assistant Superintendent), Rachel Searcy (Director of Student Services), and Corey Kessler (Director of Curriculum K-8) explained how Multi-Tiered System of Support (MTSS) integrates RTI and PBIS into a preventive framework that delivers differentiated support matched to the needs of the whole child. The historical journey of MTSS was also reviewed.

C. Federal Food Service Lunch Program

- Kelly Weldele (Director of Food Service) explained the federal lunch program and reviewed food service sales over the past 3 years. Currently, Oak Hills High School, Bridgetown Middle School, and Rapid Run Middle School do not participate in the federal lunch program. Mrs. Weldele explained the nutrition standards required to be on the federal program and the changes needed to the menu if the district moved any of the 3 schools mentioned to the federal lunch program. Mr. Bain expressed appreciation for the self-funded programs such as the Gold Star program and the Adopt a Highlander program. Mr. Bain explained the staffing and financial impacts if the board moved any/all of these buildings to the federal lunch program.

D. Transportation

- Mr. Nash (Director of Operations) shared the staffing, financial and equipment needs in the transportation department. Mr. Nash explained the current transportation policy, and the ramifications if this policy was revised to increase transportation. The district transports at the state minimum (2 miles or further) for students, except Oak Hills High School (unless the student is special needs).
