## VIII. <u>BOARD DISCUSSION</u>

A. Delhi Township - Towne Square Update - Jack Cameron Delhi Township Administrator provided an update on the mixed use project. Mr. Cameron provided blueprints of the project which includes 180 apartment units, 4 classrooms, 2 pools, and other amenities (full scope available on Delhi's website). Greg Delong (Delhi Development), Michael Collins (JSL), and Mike Combs (Health Fitness) were also present and explained the philosophy on district time in the swimming pool.

- B. Oak Hills Alumni & Educational Foundation Kim Simms, OHAEF president, provided a handout which included the foundation's mission, vision, impact and potential. Items discussed included the book bus, as well as education grants, and how the foundation continues to grow awareness of their organization.
- C. Oak Hills Title 1 Service Tim Cybulski (Assistant Superintendent), Tara Willig (Delshire Principal), and Judy Weberding (Delshire teacher), provided an update on the district's Title I program at Delshire. Funding is used mostly for staffing, which is also allocated to St. Dominic. Funding is used for targeted reading and math purposes. A handout was provided.
- **D. OHLSD Five Year Forecast** Steve Bain reviewed the five year forecast which included 2023 allocations, staffing concerns, inflation concerns, stimulus funding updates, reductions implemented, transparency & stewardship initiatives as well as the permanent improvement fund forecast. The forecast and assumptions are publicly posted on the district's website.
- **E. Strategic Planning** Jeff Brandt and Tim Cybulski provided an update on the strategic plan. The Board requested additional information on surveying the community which will be provided at another meeting.
- **F.** Board Meetings Video Options The Board of Education reviewed their policy on meetings and determined to tape (not live stream) the Board of Education meetings.
