**VI. TREASURER'S REPORT**

- Mr. Bain communicated:
  - The June and July Financial Reports
    - Fall projections as compared to actual fiscal year end figures were within approximately 1%
  - State Biennium Budget (House Bill 33) – key points including:
    - State Funding – sluggish growth projected for FY24 & FY25
      - The state funds students receive according to the “funding formula” is approximately \$8,300 per student. OHLSD receives approximately \$3,500 per student since public schools are a state and local responsibility.
    - EdChoice Expansion – Universal Vouchers
      - Funding is not deducted from the local district
      - \$6,165 K-8
      - \$8,407 9-12

- Eligibility is available for all students (sliding scale based on income), starting at full payment for families at 450% of the poverty level or below, with an assurance of at least 10%
  - Sports Gaming and School Resource Officers (included as “formula” funding)
  - Literacy & Learning Acceleration & Workforce Readiness – themes in HB 33
  - Student Wellness & Success Funding will continue to support mental health for students
  - Transportation impacts for not being in compliance (including losing funding for not transporting students)
  - Department of Education Workforce (DEW) established
    - Cabinet agency appointed by the Governor
    - Establishes Division of Primary and Secondary Education and Division of Career-Technical Education, each headed by a deputy director
  - State Board of Education duties revised as well as the Department of Children and Youth Services
- Auditor of State – Completed audit was presented, along with the award for excellence in reporting. A special thanks to the entire staff, particularly building secretaries, teachers and the Treasurer’s Office (Jamie Behrle, Kristy Berra, Brandy Hauser, Lisa Hauser, and Shannon Schwallie)
- Workers Compensation audit – the district was in compliance with the regulations of the Ohio Bureau of Workers Compensation

**RESOLUTION – DECLARE STUDENTS ELIGIBLE FOR IN-LIEU-OF TRANSPORTATION PAYMENTS**

**Mrs. Schoonover moved, seconded by Mr. West, to approve the Resolution to Declare Students Impractical to Transport and Eligible for In-Lieu-Of Transportation Payments as submitted.**

WHEREAS Section 3327.01, ORC, permits a board of education to make payment in-lieu-of transportation to a parent, guardian, or other person in charge of a student where the board of education determines that it is impractical to transport a pupil by public conveyance; and  
WHEREAS the Board of Education of the State of Ohio issued certain procedures for boards of education to utilize in making such determination of impracticability; and  
WHEREAS the Oak Hills Board of Education has fully considered Steps 2.1 through 2.6 of the State Board of Education Procedures and has determined that transportation is impractical for the students identified on the attached list and that payment in lieu of transportation should be made to the parent, guardian, or other person in charge of said students; and  
WHEREAS the payment in lieu of transportation will be the amount determined by the Ohio Department of Education as the minimum amount for each respective school year; and  
WHEREAS the names, addresses and schools of attendance for the students are provided on the attached list.

NOW, THEREFORE, BE IT RESOLVED that the Oak Hills Board of Education, after full consideration of all the criteria set forth by the State Board of Education, determines that pupil transportation is impractical for the students listed and that payment in lieu of transportation by school conveyance is necessary.

BE IT FURTHER RESOLVED that the Superintendent of Schools is hereby directed to seek the consent of the parent, guardian, or other person in charge of said students for payment in lieu of transportation.

BE IT FURTHER RESOLVED that a copy of the within Resolution be submitted to the County Board of Education pursuant to Section 3327.02, ORC, with a request that the County Board of Education affirm the within action.

BE IT FURTHER RESOLVED that consents to this determination from parents, guardians, or other persons

in charge of students in this District shall be submitted to the State Board of Education for confirmation. BE IT FURTHER RESOLVED that failure of a parent, guardian, or other person in charge of students to consent to the determination that transportation is impractical shall be submitted to the Superintendent of Public Instruction for fact finding and mediation.
