Request for Proposal Lawn Services December 19, 2018

Description of Request

The Oak Hills Local School District is requesting proposal for lawn care service (including all court yards). Areas to be serviced are on page 2 of this document. The areas to be mowed do not include the turf area at the high school stadium.

For contractors interested in walking the properties, please call or email John Beckemeyer (beckemeyer_j@ohlsd.org) by January 1, 2019 (513-574-3200). Mr. Beckemeyer will show all interested contractors the properties on January 3rd at 8AM (please gather at the District Office 6325 Rapid Run Road, Cincinnati, OH 45233). The responsibility of verifying acreage to be serviced rests with the contractor.

The District may select a contractor based on, but not limited to, items such as quality, references and financial considerations.

Scope of Work

- 1. Twenty eight (28) cuttings throughout the mowing season.
- 2. Mulching all beds one time per year (in the spring) and ongoing maintenance.
- 3. Trimming of shrubs/landscape beds & pre-immersion for weed control.
- 4. Trim curbs, sidewalks, fences, poles, etc. after each of the twenty eight (28) cuttings.
- 5. Remove all grass and trimmings from pavement, sidewalks, benches, and other like common areas upon the completion of each cutting.
- 6. The contractor will be responsible for the removal of fallen leaves, branches etc.
- 7. In good faith, the contractor shall maintain a 3 inch cutting height.
- 8. The contractor also agrees to work with the district where special circumstances require the contractor to work special hours due to class schedules, testing dates or other special circumstances.
- 9. The contractor must keep a safe distance from any student activities taking place on the premises while mowing or trimming.
- 10. The contractor must have in place an alternative plan in the event of failure of any mowing equipment. A point of contact from the contractor must be provided, available 24 hours a day, 7 days a week, including holidays that will ensure a response time of 4 hours or less.

Terms

- 1. Twenty-eight (28) cuts per district property specified in the agreement (the contractor will also provide an hourly rate for additional requests).
- 2. The contractor shall bear the cost of the School Employee Retirement System (SERS).
- 3. The contractor will invoice the district in eight (8) even billings on the first day of the following months (April, May, June, July, August, September, October, November). Payment shall be made to the contractor within 30 days of receiving the invoice.
- 4. The contractor shall maintain liability insurance in the amount of one million dollars (\$1,000,000) and will provide a Certificate of Liability Insurance to the Director of Operations that names the Oak Hills Local School District as an additional insured.
- 5. The contractor shall also provide proof of Ohio Bureau of Workers' Compensation coverage for employees engaged in working on the school site.
- 6. The contractor shall be responsible for all workers compensation claims (including legal fees).
- 7. The contractor shall comply with all Board of Education school policies and procedures.
